We have supported local adaptation projects, partnered with community-led organizations, advocated for global policy change and spearheaded efforts to provide real-world evidence on effective local solutions.

Building on the legacy of the My Child Matters Program, we have made strides in increasing survival rates for children with cancer. This includes capacity building for healthcare professionals, supporting children and families with holistic care, and influencing the field through extensive knowledge sharing.

Humanitarian aid and medicine donations

Our humanitarian aid and medicine donations have supported vulnerable and displaced populations during times of crisis and beyond. We have partnered with diverse organizations at local, regional and global levels to strengthen coordination, broaden our reach and increase our impact.

Eliminating sleeping sickness

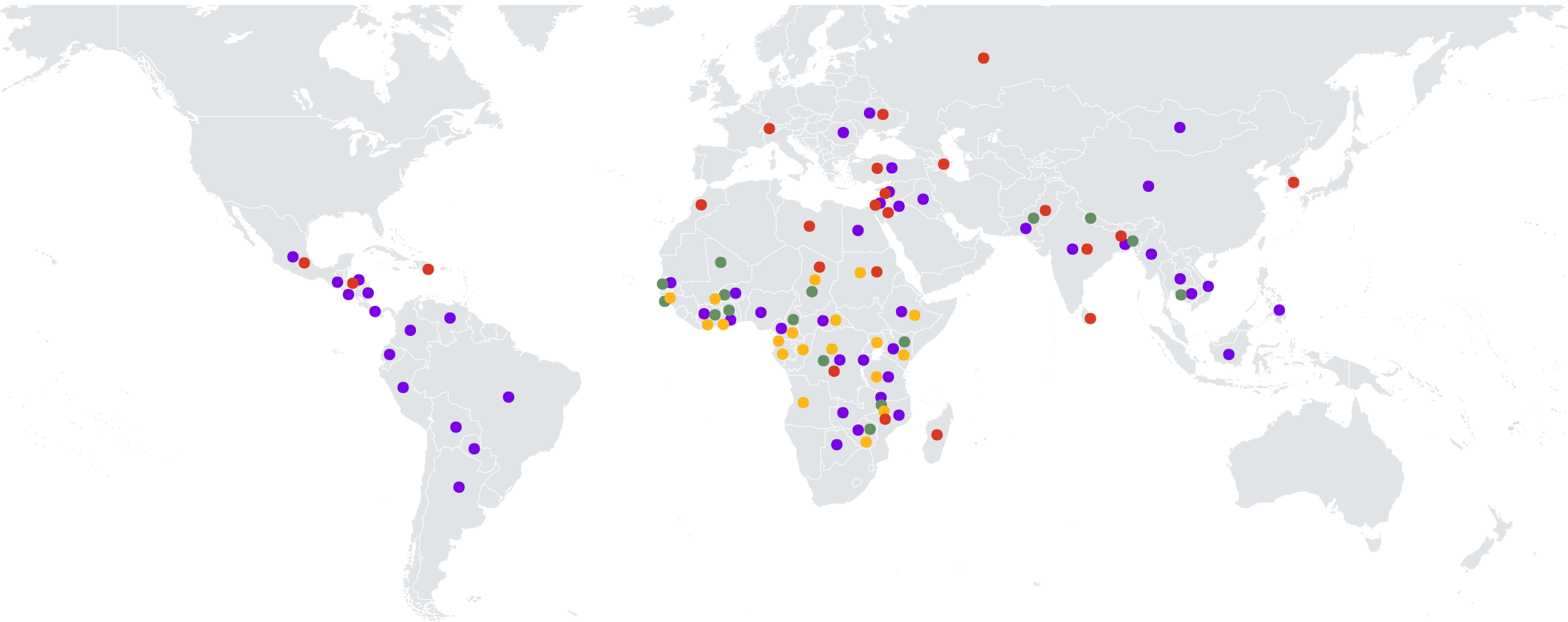

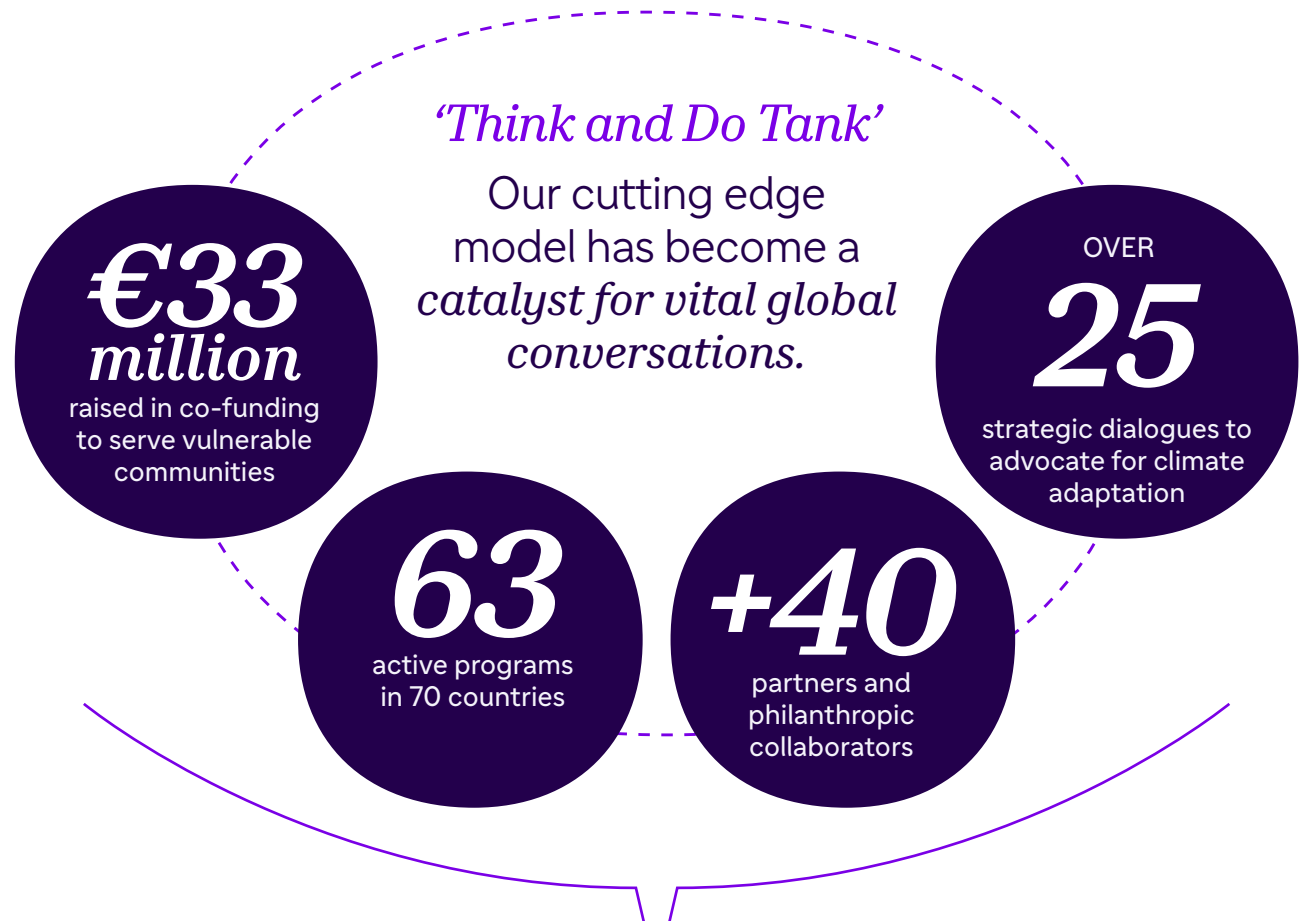

Through this unique dual philosophy, we work with global experts and thought leaders, fostering a *'Think Tank'* style exchange of cutting-edge ideas to tackle health challenges in low and middle income countries. We go beyond being a forum for dialogue to actively translate these insights into action.

As a *'Do Tank'* we address these challenges through robust collective action, spirited advocacy and raising awareness, and we work with communities to bring great ideas to scale that address the health challenges they face. Our approach is grounded in data and evidence, ensuring each step we take is informed and impactful.

We've taken center stage in international forums, igniting urgent dialogues on critical issues like climate adaptation and health, the fight against sleeping sickness, reducing cancer treatment abandonment, and expanding medicine donations.



Foundation S is not just participating in change; we are *actively driving it*, leveraging our unique model to make tangible, *impacts* where they're needed most.



Together, we are committed to improving the lives of vulnerable people through *community-based solutions* that are both innovative and evidence-based

At the heart of Foundation S is a *powerful mobilization* of Sanofi's workforce and an alliance with diverse partners

- Our team of leaders oversees each of the four commitment areas as well as cross-cutting initiatives. Despite being an independent entity,

Foundation S also leverages the know-how and expertise of Sanofi employees, also known as The Sanofi Collective, to strengthen its work and ensure effective strategic implementation.

- Mobilizing and engaging Sanofi employees is central to how Foundation S operates.

We employ a dynamic five-step pathway to ***revolutionize the lives of vulnerable populations***, using community-based solutions and broadening access to medicines globally.

Our five-step strategy tackles challenges at the individual, public health, and system levels

Step 1 Tools

Foundation S adopts an entrepreneurial spirit and agile methods, utilizing several levers to *jumpstart our impact journey*. We leverage our existing networks and access to diverse stakeholders for know-how, expertise and resources, tap into established networks, convene diverse stakeholders, and form strategic partnerships with a specific focus on community focused and led programming.



Step 2 Programs

Our activities span grant-making for sustainable, local initiatives, education and training programs, advocacy to influence policies, and collaborations with local partners and experts for collective action. We work with partners to develop medicines for neglected tropical diseases and provide aid in crises through medicine and financial donations.

Step 3 Results

We work to bolster healthcare workforce capacities and community resilience to health and climate challenges. We promote equitable access to diagnosis and treatments, enhance health outcomes through digitalization, and generate vital data for tackling health and climate issues.



Step 4 Goals

Our initiatives lead to four key outcomes: reinforced public health ecosystems, improved health across our commitment areas, data-informed policymaking, and demonstration of an optimized philanthropic model.

● Climate Action & Health Resilience

Supporting vulnerable communities *to adapt and build health resilience to the impacts of climate change*

In 2023, Foundation S made significant strides in bolstering community-level climate adaptation and driving global advocacy for climate action.

Empowering communities, strengthening health resilience

Climate change is a public health emergency. In many vulnerable countries, the harmful effects of climate change severely impact already weak primary healthcare systems and compromise people's ability to access essential health services.

Foundation S aims to increase the health resilience of these communities impacted by climate change, focusing on the thirty countries listed in the [Notre Dame climate vulnerability index](#).

Our approach involves grants for community adaptation projects, collaborating with regional

strategic partners, and gathering data for policy change.

Twenty-two grantees working on community health systems and climate resilience – including capacity building of healthcare professionals, developing local early warning systems and community preparedness, climate-smart agriculture and food security, water, sanitation and hygiene – were selected out of 137 project submissions, each with a strong focus on community empowerment and local adaptation to climate change for improved health outcomes.

Capturing data for collective action

Collect data to better understand the health impacts of climate change in LMICs and document community experience and stories for use in implementation science.

Data-driven advocacy and policy action

Advocate for increased investment in climate health adaptation and policies focusing on support for vulnerable populations and working with partners for collective action.

Grantee projects in action

Improving climate resilience in Bangladesh and Kenya



In the remote Gaibandha region of Bangladesh *Foundation S support has enabled Friendship to deploy 700 community health workers, benefiting 10,000 individuals during environmental crises* and helping to provide sustainable capacity strengthening for a more climate-resilient health system. Using healthcare boats, Friendship has provided essential healthcare to remote populations otherwise inaccessible because of climate change.

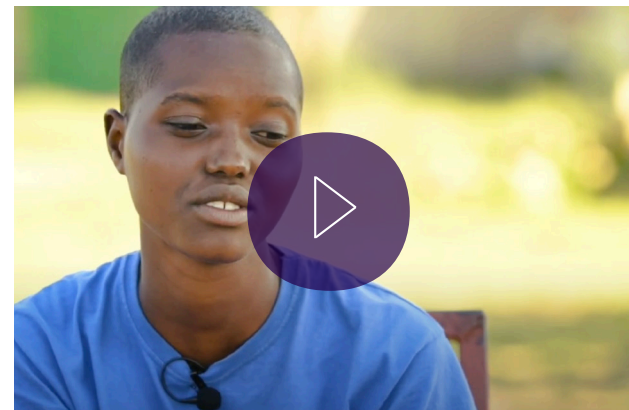

This project has a strong gender component, empowering women to lead and ‘own’ community initiatives to increase climate resilience.

Driving global advocacy

for climate action, global health & climate agendas



Foundation S identified two strategic partners as Regional Accelerators, leveraging their extensive multi-country reach. These partners act as ‘big brothers and sisters’ to smaller local organizations, aiding in capacity building and their community-driven projects.

In 2023, the Council highlighted the multifaceted impacts of climate change on health and the essential need for supporting and financing local communities. Their year-long strategic dialogue culminated in the publication of “Time to Adapt: Accelerating Climate Adaptation for Health Equity,” an action report launched on the sidelines of the United Nations General Assembly. This event brought the report to the attention of global leaders and policymakers, underscoring Foundation S’s commitment to health equity and resilience in communities most affected by climate change.

Calling for action at the highest levels

Between 2022 and 2023, Foundation S convened high-level events, spearheading crucial dialogues on integrating health into climate finance and policy. We facilitated the exchange of best practices and rallied global partners at significant gatherings, including the World Health Summit, the Summit for a New Global Financial Pact, the Paris Peace Forum, and the inaugural Health Day at COP28.

Furthermore, Foundation S collaborated with Foreign Policy and the Africa-Europe Foundation at the 78th UN General Assembly, spotlighting climate change’s detrimental impact on global health. The event, attended in-person and virtually by over 1,000 people, facilitated crucial dialogues on the global health climate crisis, emphasizing the need for comprehensive strategies to tackle this growing challenge.

Our focus

We will prioritize projects that are both led by and beneficial to the long-term resilience of local communities. This involves backing initiatives that enable communities to autonomously tackle climate-related challenges, placing control and decision-making power directly in their hands.

Bridging *the gap*

 *Every 3 minutes, a child's life is cut short by cancer*

There are 400,000 new cases in children and adolescents annually. This stark reality highlights a **critical global health disparity**: while over 80% of young cancer patients in high-income countries access treatment that leads to a cure, in low- and middle-income countries (LMICs), this rate plummets to 20 to 30%.¹

This gap underscores the **urgent need** for more pediatric cancer research, care and funding.

The challenges in LMICs are complex: late detection, scarce well-trained healthcare professionals, limited pain management and palliative care, and less focus on childhood cancer among other health priorities. Appropriate treatments are often unavailable or financially out of reach for many.

Foundation S is determined to bridge this gap.

We are dedicated to transforming pediatric cancer care in LMICs, working alongside local health systems, NGOs, and regional and international stakeholders to adapt resources to regional needs and enhance pediatric cancer support.

Our strategic focus is twofold

1

→ **Quality of life:**

Improve the quality of life for children with cancer and their families in LMICs, from diagnosis to treatment.

2

→ **Local capacity building:**

Invest in the training and capacity-building of doctors and nurses and empower local healthcare professionals to deliver high-quality pediatric cancer care and treatment.

Foundation S works flexibly alongside partners to collectively pursue the goal of improving survival rates for children with cancer. The journey is a collaborative effort, with grantees

equally engaged in setting benchmarks for reporting and knowledge creation right from the project's inception.

This synergy ensures that every step we take is informed, impactful, and tailored to the needs of those we serve.

We have strong partners across Latin America, Africa and Asia. They strengthen our work at both global and regional levels and bring a balance between scientific, policy and civil society focus.

The Childhood Cancer Expert Committee is a diverse, high-level international expert committee comprising pediatric oncologists, nurses, family members of children undergoing cancer treatment, global health specialists, and other key stakeholders in childhood cancer.

The Committee advises Foundation S and is involved throughout the My Child Matters Grant Program from reviewing initial applications to the selection process, offering mentorship and ongoing support to grantees.

Looking forward

We will continue working towards critical milestones in childhood cancer care, aligning with the World Health Organization's goal of a 60% survival rate.

→ *Home Away from Home Initiative with Childhood Cancer International*

Foundation S is committing to supporting children with cancer and their families by investing in the Home Away from Home initiative. This programme aims to reduce treatment abandonment and enhance wellbeing by supporting organizations to provide a second home for patients and their caregivers close to health services.

→ *Focus on Latin America*

We aim to amplify our impact in Latin America by organizing a childhood cancer conference in the region. This effort will be complemented by monitoring visits to ensure the success and sustainability of projects.

→ *Embracing Digitalization*

We will continue to invest in and leverage the Open Data platform. This strategic decision reflects Foundation S commitment to utilizing digital tools to expand the reach and effectiveness of our initiatives, ensuring a modern, impactful approach.

Supporting vulnerable and displaced populations during emergencies

Our focus is on *dismantling barriers* to collaboration, aiming for a collective impact in crisis response.

Dismantling *the barriers to collaboration*

 *Humanitarian crises are escalating worldwide*

The situation for displaced people, especially in low- and middle-income countries, is reaching a critical point due to war, persecution, and violence.

Climate change is increasingly recognized as a catalyst for migration and conflict, with projections indicating that Latin America, sub-Saharan Africa, and Southeast Asia could see as many as 143 million climate-related migrants by 2050.²

In response to these growing needs, Foundation S supports strategies for maximum effectiveness. Our focus is on dismantling barriers to collaboration, aiming for a collective impact in crisis response.

We've made progress, including developing emergency preparedness protocols and being an inaugural member of WHO Foundation's Health Emergencies Alliance.

Foundation S plays a role beyond immediate crisis response at a more strategic level. As well as donating medicines, we're contributing to the strengthening of international donation guidelines.

We aim to facilitate a transition from a reactive to a proactive medicine donation approach and boost efficiency, even in less severe ongoing crises.

Foundation S amplifies its *humanitarian impact*

Collaborating with a diverse range of NGO partners at global, regional, and local levels.

These include the Partnership for Quality Medical Donations (PQMD), Tulipe, the International Committee of the Red Cross (ICRC), Direct Relief, Ordre de Malte, Friends for Health, Helping Hands Korea, HelpUkraine, AiFD20, various ministries of health and development agencies across the globe. This network of partnerships broadens Foundation S' reach and enhances the effectiveness of its aid efforts.

Since May 2022, Foundation S has coordinated 71 donations, including financial and medicinal aid, across 23 countries, amounting to €52 million. This

work involved over 9,000 committed Sanofi employees, resulting in 55 million daily treatments and positively affecting the lives of 22 million people.

In prolonged conflict zones such as Ukraine, Sudan, and Karabagh and in emergencies like the Turkey/Syria and Morocco earthquakes and Hurricane Otis in Mexico, Foundation S has worked on multiple fronts, from logistics and research and development to commercial divisions. This collaboration enabled the rapid and efficient distribution of life-saving medications to communities in need during these crises.

Our vision to 2030 is to revolutionize the treatment landscape for vulnerable communities, making the sustainable elimination of sleeping sickness a tangible reality.



The battle against *sleeping sickness*

 *Harnessing innovation and partnerships to overcome Neglected Tropical Diseases*

Sleeping sickness, or Human African trypanosomiasis (HAT), poses a significant threat in remote African communities. This fatal disease, caused by parasites transmitted by tsetse flies, requires urgent treatment.

Despite a significant reduction in cases thanks to improved control and treatment options, the complexity of administering these treatments remains a hurdle in hard-to-reach populations.

Foundation S' work on sleeping sickness is supported by strong public and private partnerships, including our long-term collaboration with WHO and the non-profit Drugs for Neglected Diseases Initiative (DNDi).

This cooperative approach is pivotal in revolutionizing the treatment landscape, ensuring sustainable access to care, and aligning with WHO's ambitious goal of eliminating sleeping sickness by 2030.



Our strategy focuses on:

Saving Lives

Collaborating with WHO, we are dedicated to ensuring that every patient with sleeping sickness can access safer and more effective medicines.

Innovating for the Vulnerable

In partnership with DNDi, we aim to introduce Acoziborole as a novel and effective treatment for adult patients.

Our ambitions will be pursued through educational programs, drug donations, and the development of new, simplified treatment methods.



Foundation S, Sanofi, WHO and DNDi developed fexinidazole, the first-ever complete multi-dose oral treatment for sleeping sickness.

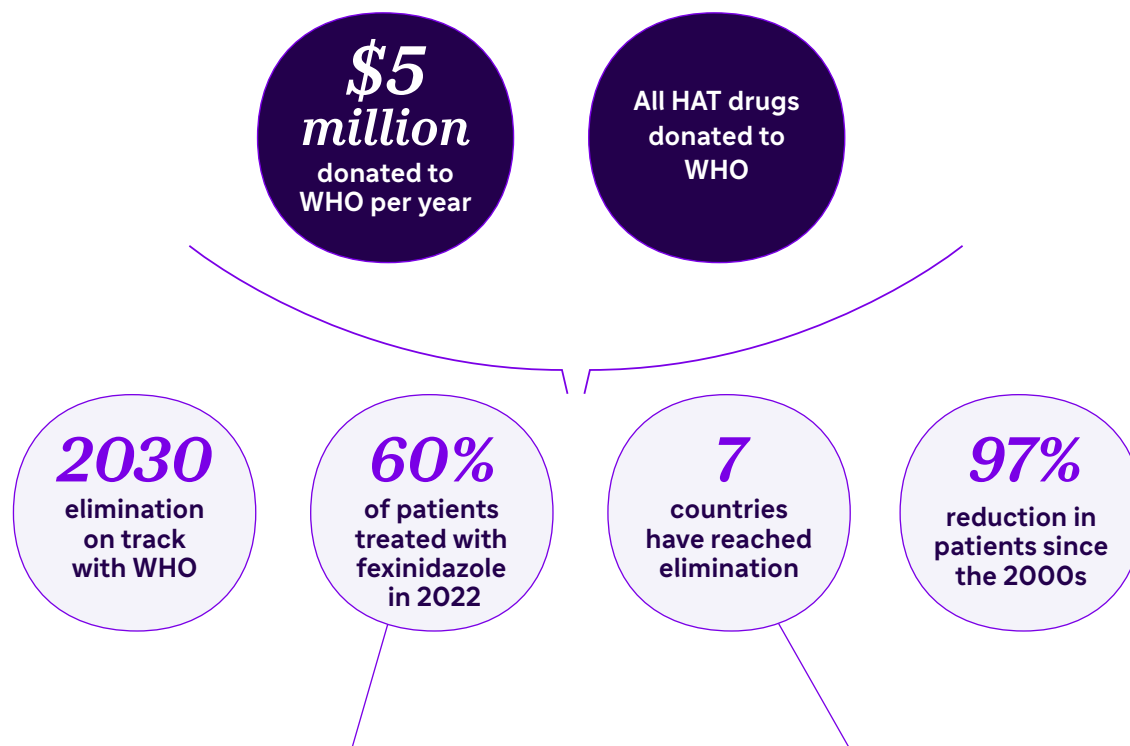
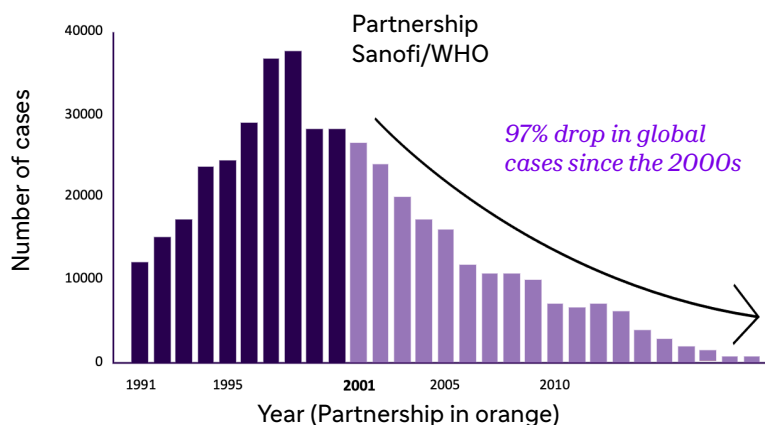
Building on this success, we are now focused on introducing an investigational innovative single-dose oral treatment (Acoziborole) for patients.

Over the last decade, the fight against sleeping sickness has undergone a *transformative shift* towards elimination and better treatment access

Central to this shift are collaborations between Foundation S, Sanofi, WHO, DNDi, Médecins Sans Frontières, and national sleeping sickness control programs in the Democratic Republic of the Congo and Guinea, among others.

This coalition has adopted a multi-faceted approach, integrating sleeping sickness control into national health systems. Efforts include raising awareness, training health workers, advancing treatments through research and innovation, and maintaining a stable supply chain.

Sanofi and Foundation S have been instrumental in ensuring medication supply, especially to remote regions typically overlooked by the pharmaceutical market. Their 20-year partnership with WHO has significantly contributed to a 97% drop in global cases since the early 2000s, moving the world closer to eliminating sleeping sickness – a historic feat potentially achievable without a vaccine. This ongoing commitment underscores the power of global collaboration in public health.



Angola, Cameroon, the Central African Republic (CAR), Chad, the Republic of the Congo, the Democratic Republic of Congo (DRC), Equatorial Guinea, Gabon, Guinea, and South Sudan have successfully integrated fexinidazole into their treatment protocols.

Togo, Cote d'Ivoire, Benin, Uganda, Equatorial Guinea, and Ghana have proudly announced their success in eliminating the Gambiense strain of sleeping sickness, while Rwanda has shown progress in eliminating the Rhodesiense strain.

Foundation S, Sanofi and DNDi: *a longstanding partnership*

Foundation S, Sanofi, and DNDi form an important alliance in the fight to eliminate sleeping sickness by 2030. In November 2022, we announced the successful trial of Acoziborole, a single-dose oral treatment for the disease. If approved, Acoziborole will be a game-changer, simplifying treatment with its one-day treatment and enabling a ‘screen-and-treat’ approach, which is crucial for remote and underserved communities.

This breakthrough, due to DNDi’s extensive research and Sanofi’s production expertise, represents *a significant step towards eliminating sleeping sickness* and making treatment more accessible and efficient for all, especially children.
