# 1 Shares and dividend

### How can I see the share price?

Shares must be held at the latest on the record date.

We invite you to contact directly the bank holding your shares. The bank is Uptevia if you have administered registered shares or fully registered shares.

# Can you send me the dividend dates (ex-dividend date, record date, payment of dividend)?

I received by donation shares of the company Sanofi (notarial deed). To date, it seems that no steps have been taken to carry out this transfer. Could you tell me what documents and procedures are necessary to make this transfer?

### Does Sanofi have a dividend re-investment plan?

Sanofi doesn't have a dividend re-investment plan for ordinary shares.

#### How to transfer shares after the death of a shareholder?

You will need to directly contact the bank/financial intermediary holding these shares.

## When and where is the next general meeting?

### How to participate to the next general meeting?

Pure and administered registered shareholders receive the invitation to participate to the annual general meeting because they are registered in the company's registers. If you are a bearer shareholder, you can ask your financial intermediary for a certificate of your status as a shareholder. The financial intermediary must then forward it to Uptevia who will send you your admission card.

#### I would like to vote to the next general meeting. Can you tell me how to proceed?

To vote, you will need to log in to PlanetShares. Access information, login and password, are to be requested from Uptevia if you do not know them.

# I am a Sanofi shareholder and wish to vote at the general meeting. Can you please let me know how to proceed?

If you attend the general meeting, it will be provided to you as appropriate:

- A ballot paper,
- An electronic box

If you vote online,

- If your shares are bearer shares: check with your account holding institution to see if it is connected to VOTACCESS. In this case, identify yourself on its web portal with your usual access codes.
- If your shares are registered, access VOTACCESS via Planetshares: <a href="https://planetshares.uptevia.com">https://planetshares.uptevia.com</a>
- For pure registered shares: with your usual access codes
- For administered registered shares: with the identifier on the paper form attached to your invitation

If you vote by mail,

- If your shares are bearer: request the voting form from the financial intermediary that manages your securities. You must return this voting form with the certificate of participation to Uptevia
- If your shares are registered: return the voting form to Uptevia
